Pakistan Software Export Board (PSEB) is the government agency mandated to promote the Pakistan's IT industry.

PSEB is a guarantee limited company totally owned and funded by the Government of Pakistan. It is under the administrative control of the Ministry of Information Technology and Telecommunications, and has a Board of Directors that is chaired by the Minister of IT and Telecommunications.

Through its many support programs, PSEB aims to help Pakistani companies and professionals in obtaining a greater share of the domestic as well as the global IT and ITeS market place.

2 Major Functions of PSEB

Since 1995, PSEB has been facilitating the overall development of the IT industry in general, and the export of software as well as IT enabled services in particular. Major functions are as follows:

- o Formulate and implement policy frameworks and incentive packages for the IT industry.
- o Act as an interface between the Government and the IT industry.
- o Interact with the relevant regulatory bodies to develop the enabling infrastructure.
- o Conceptualize and execute projects for the development of the Industry.
- o Enhance the quality of IT education.
- o Resolve problems/concerns of the IT industry with relevant government quarters.
- o Address queries by overseas companies or direct them to the appropriate channels.
- Maintain the competitiveness of the local IT industry in the international market by creating a viable domestic environment.
- o Bring IT companies under one platform.
- o Market Pakistan as a viable IT Destination
- o Monitor developments within the global IT sector and formulate / implement polices to adjust for the changed environment.
- o Accelerate the growth of the domestic IT Sector.

4 Objectives of this Advertisement

The objectives of this advertisement is to assist 10 more companies on ISO27001. PSEB shall bear 80% Consultancy and Audit cost of ISO27001 and 20% will be paid by the company.

5 Purpose of this Document

The purpose of this document is to specify the approach that PSEB will use to evaluate and select Software Companies for enrollment into this program. This document also describes the requirements that the company has to fulfill in order to be selected.

6 Selection criteria

Mandatory Requirements

1. **PSEB Registration**

Company should be a PSEB registered company.

2. ISO 9001:2000 or ISO27001 certification

Only the companies having a developed internal system against ISO9001:2000 standard and audited by external auditor will be selected.

3. Share Holding of the Company

At least 50% of the shares of the company must be held by individuals holding Pakistani Nationality. Documention needs to be provided to this effect. Companies with less than 50% Pakistani shareholders would be disqualified.

4. GOP Eligibility





The section disqualifies the companies black listed by any division, department or organization of Government of Pakistan

Evaluation Criteria

1. Number of years in IT Business

This section gives an advantage to the companies that have more experience in terms of number of years. There is no disqualification in this section however.

2. Export registered to SBP during FY 2014-15

This section checks the company's performance in the three years preceding the proposal submission.

3. Domestic Business during FY 2014-15

This section gives an edge to the companies that have been concentrating over the domestic market as well. There is no disqualification in this section.

4. Projects in Hand

This is to check the company's sustainability in near future. The more projected revenue companies will show through their contracts in hand, more advantage will they get over others.

5. Number of Employees

This section checks whether a company has sufficient human resource to implement ISMS. This also gives an edge to companies that have a larger number of human resources. The companies with less than 10 employees will be disqualified automatically.

6. Projects pertaining to sensitive data handling

If the company is following standard security practices and has projects pertaining to "sensitive information handling" then they will be given preference.

7 Documents Required

(These documents are mandatory and will have a strong impact on the selection)

- 1. Certificate of Incorporation / Proof of Establishment
- 2. Copy of PSEB membership certificate
- 3. Detailed company profile
- 4. Copy of ISO 9001 Certificate.
- 5. Company Human Resource Strength (Detail of Employees returns filled with Tax Department for during the previous year OR Return of Employee filled with EOBI OR Copies of instructions issued to the Banker regarding transfer of salaries of employees for the month of January, 2016)





- 6. Detail of the company's shareholding (issued by SECP). Provide the copies of National ID Cards of the Pakistani shareholders. Also provide details about the Nationalities of foreign shareholders.
- 7. Export Proceed certificate issued by the bank, for the last three years (e.g. Export Realization Certificates) OR Sale Bills reported to the State Bank of Pakistan on prescribed format with respect to export.

(Note: All companies will have to submit their share of 20% of ISO27001 consultancy within 30 days of selection. Failing to do so, company's selection will stand as void: however the audit share to be borne by the company needs to be paid later after completion of consultancy)
